# WHOLESALE ACCOUNT AGREEMENT TERMS AND CONDITIONS FOR MAJOR CREDIT CARD BILLING

The following terms and conditions apply to purchases made on Solstice Medicine Company wholesale accounts. Use of such accounts constitutes acceptance of the terms and conditions in effect at the time of purchase. This Wholesale Account Agreement is between you as the Customer and Solstice Medicine Company.

### 1. PURPOSE OF A WHOLESALE ACCOUNT WITH CREDIT CARD BILLING

This wholesale account program is specifically designed for companies to use a major credit card to purchase products from Solstice Medicine Company for resale purposes. A wholesale account may not be used for personal purchases. Solstice Medicine Company products and the product names and trademarks may not be used for any commercial or promotion purposes, without the authorization and consent of Solstice Medicine Company.

### 2. ADMINISTRATORS AND AUTHORIZED PURCHASERS

Customer employees designated as Administrators are authorized by the Principal to make changes to the account. Employees designated as Authorized Purchasers are authorized by the Principal or Administrator to use a business credit card to make purchases on behalf of the Customer. A designated Administrator may or may not be an Authorized Purchaser.

### 3. CHANGES OF INFORMATION

Updated Customer business account information (i.e. company name, authorized purchasers, etc.) is required annually. All changes must be provided to Solstice Medicine Company by letter, by e-mail or by accessing the sosusaco.com Web site.

## 4. EXCLUSIONS

Your wholesale account may be used only for orders that are shipped within the United States.

#### 5. WHOLESALE PRICING

Purchases made by the cardholder are eligible to purchase our products at wholesale prices.

#### 6. QUANTITY

Solstice Medicine Company reserves the right to limit the quantity of merchandise sold to any Customer.

## 7. NO PURCHASES FOR PERSONAL USE

By purchasing merchandise on a wholesale account, Customer represents that such merchandise is not purchased for personal use.

#### 8. RETURNS

Purchases may be returned in original condition for credit within thirty (30) days of shipment unless designated non-returnable at time of purchase. Excess or habitual returns may subject the account to closing.

### 9. RIGHTS TO TRADEMARK DESIGNS

Solstice Medicine Company retains the rights to all product trademarks designs
